SuperUser RiskAssess allows health and safety managers to easily monitor science experiments in their group of schools. With SuperUser, you can:

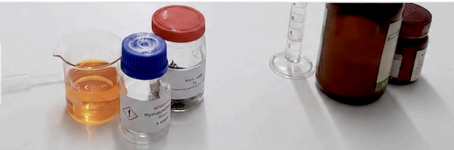
- Identify schools in need of further training and see trends, with a report on the number of risk assessments performed at each school over each of the past 3 school years
- Find schools using particular dangerous chemicals, equipment or biologicals
- View the numbers of risk assessments with a low, medium high or extreme level of inherent risk at each school
- See if schools are using electronic signatures effectively to provide an immutable legal record, with a report on the number of archived (fully signed) risk assessments
- Find risk assessments being done by a specific teacher
- See distribution of risk assessments by year group
- Check subscription status of schools and date of subscription commencement.

Searches can be focussed on an individual school to allow detailed analysis of recent risk assessments using the above search box. It is easy to switch between different schools with the drop-down list of schools in the group. All reports and searches are fully sortable and all reports can be downloaded for further analysis in Excel.
